On November 7, 2015 at approximately 1830 hours, my partner Officer Asuncion #36248 and I, Officer Carrillo #40854 were working Northeast Division. We were assigned patrol unit 11A62 dressed in full uniform driving a marked black and white patrol vehicle. We received a radio call of a "415 man at the Church of Scientology located at 4810 W. Sunset Bl." Incident# 151107003647, RD 1151.

Investigation:

Upon arrival, my partner and I met with the first responding unit 11A72, Officer Lopez #38805 and his partner Officer Stauber #41178. They advised us that they had a suspect in custody for sexual battery. I spoke with the Victim/ PPA – Long, Ken who stated that the Suspect- Myers, Donald is not welcomed on the property. He stated that at approximately 1815 hours, the suspect was trespassing inside a lobby building where religious church services were going on. The suspect was being loud and disrupting the church services. The victim responded to escort the suspect out of the lobby. While he was attempting to escort him out, the suspect tried to hit the victim but the victim blocked his arm. After the suspect was unsuccessful at hitting the victim, he reached around him and grabbed his butt. The victim was upset over the suspect grabbing an intimate body part. The victim and another security guard West, Montana was able to bring the suspect outside and wait for police to respond.

Myers was read his rights by Officer Asuncion, per LAPD form 15.03.00 where he stated "Yes, yes, yes, yes, and No." He stated he wanted to talk to his lawyer.

Arrest:

Suspect Myers was placed under private person's arrest for 243.4 (e) (1) PC- Sexual Battery. Myers was transported to Northeast Station for pre-booking approval.

Booking:

My partner and I booked the Suspect at MDC Jail for private persons arrest for 243.4(e) (1) PC- Sexual Battery on approval of Northeast Watch Commander Sgt. Bowler #30576, booking number 4495025.

Injury/ Medical Treatment:

The suspect was seen at MDC dispensary for his high blood pressure, HIV and anxiety.



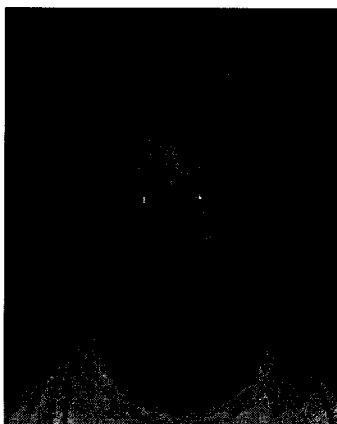
